ORDER

THIS CAUSE comes before the Court on Receiver Miranda L. Soto's (the "Receiver") Motion for Approval to Dismiss, and Dismissal of, Third-Party Complaint Against Kelley & Grant P.A. and Jerron Kelley (the "Motion") (DE [163]), filed on April 21, 2025. The Court has reviewed the Motion and is otherwise advised in the premises.

On December 31, 2024, the Receiver filed a Motion for Approval to Pursue Claims Against Third-Parties Kelley & Grant, P.A. and Jerron Kelley (DE [152]) and her Supplemental Third-Party Complaint Against Kelley & Grant, P.A. and Jerron Kelley (DE [153]). On January 15, 2025, the Court granted the Receiver's Motion for Approval to Pursue Claims Against Third-Parties Kelley & Grant, P.A. and Jerron Kelley. (DE [154]).

Now, Receiver seeks approval from the Court to dismiss the Third-Party Complaint and for an Order dismissing the Receiver's Supplemental Third-Party Complaint Against Kelley & Grant, P.A. and Jerron Kelley with prejudice. Receiver notes she has "determined that the likely potential costs, in both time and money, outweigh the potential benefits in pursuing the Third-Party Complaint" and that it would "delay and reduce the distribution of remaining estate assets to the defrauded investors. . ." (DE [163] at p. 2-3). Accordingly, it is hereby:

ORDERED AND ADJUDGED that:

- 1. Receiver's Motion for Approval to Dismiss, and Dismissal of, Third-Party Complaint Against Kelley & Grant, P.A. and Jerron Kelley (DE [163]) is **GRANTED.**
- 2. The Supplemental Third-Party Complaint Against Kelley & Grant, P.A. and Jerron Kelley (DE [153]) is **DISMISSED WITH PREJUDICE.** Each side will bear its own attorneys' fees and costs.
